Shareholder and corporate management body meetings during COVID-19: new FAQ published

Minister of Justice Koen Geens has published an [FAQ on the 9 April 2020 Royal Decree](#) regarding the organisation of general (shareholders) meetings, and meetings of corporate management bodies, in the context of the ongoing COVID-19 pandemic (previous coverage can be consulted in the [6 April](#) and [16 April 2020](#) newsflashes).

This FAQ provides scope of application guidance on the measures proposed in the 9 April 2020 Royal Decree, with some practicalities regarding meetings held by teleconference or videoconference.

Entity management in the framework of the approval of annual accounts

The formalities relating to the approval of annual accounts and other corporate events are often regarded as an administrative burden.
